A dynamic duo as close to superheroes as anyone could want, Chris and Owen have been teamed up since Owen was hired in late July 2021. Prior to starting with Banchero Disability Partners, Owen worked in the graphic design industry, but was involved in disability advocacy for several years as a student at the University of Oregon and a youth leader. He had been looking to make an impact in the disability community again, and we jumped at the chance to bring him along on our mission.

Setting the Scene

Chris' day to day life in one word is poetic. Mornings are spent contemplating "the meaning of it all", with not nearly enough coffee to figure it all out, and using his signature style of ballpoint pen on lined paper to create intricate sci-fi landscape art (which is also discretely tattooed on him nearly head to toe). Owen joins Chris most mornings to bring him back to earth by supporting him with the mundane tasks to keep his household in order: meal-prep, budget planning, scheduling cleaning and laundry sessions, and most importantly planning trips into the community for work and shopping of all kinds.

Meet Our Protagonists: Chris and Owen (Continued)



Chris is a lover of analog media, and one of his favorite pastimes is watching Blu-ray horror movies and purchasing used DVDs at the Silver Platters in Lynnwood.

Naturally, one must own top of the line DVD players and TVs to fully enjoy this lifestyle and when possible, Chris likes to upgrade his gear. Leading up to his 55th birthday, Chris planned to upgrade his TV and soundbar to create a home movie viewing experience to rival the IMAX at Seattle Center. Chris worked with Owen on his budget for two months, researched the TV and soundbar he wanted, and arranged a trip to make the purchase. When Chris arrived at the electronics store, with list in hand and items packed and ready at the register, his check was denied.

An Unexpected (and Unwarranted) Plot Twist

The denial is a phenomenon of the pandemic, completely unrelated to the balance in Chris' checking account. Many large stores have begun using a third party screening company to conduct random credit checks at the point of sale in order to prevent people from passing fraudulent checks. A huge consequence of this practice is that many people, who are required to have financial support services like our clients, do not have credit history and are automatically flagged as bad actors, thus declined from making purchases at these stores. This practice greatly impacts individuals with disabilities, those who are homeless, and others whose circumstances provide legitimate reasons for not having stellar credit reports. It's a disappointing feeling to get so close to something you've been looking forward to for months, just to have it slip out of reach. The disappointment and frustration only grows when you know you have the resources available to you and are unfairly denied because you have a disability. If you're Chris, you have no choice but to leave the store empty-handed and call the company to figure out if there is anything you can do.

Having lived in institutions before coming to Banchero Disability Partners, Chris is no stranger to discrimination, even extreme forms leading to false accusations and near criminal records. Miraculously, through all these experiences, Chris typically prefers to take the high road and not waste the day being upset with things outside of his control.

This situation did not sit well with Owen. He became increasingly frustrated with the check company after advocating that they mark Chris as a credible customer, just to have Chris get a second denial the following day. Owen encouraged Chris to engage in a customer complaint escalation with the Attorney General's office. They hope to use his experience to change this practice and benefit those who are also at risk of financial discrimination but have yet to face the embarrassment and marginalization that accompany it.

Chris is now scheduled to meet with a representative from the Attorney General's office to advocate for change. It is because of the generous support of donors like you that we are able to attract talented and caring people like Owen, who will go above and beyond to empower clients to address issues like financial discrimination. It takes time and persistence to affect systemic discrimination, and although there have been vast improvements to protect the civil rights of people with disabilities, there are always new obstacles to be overcome.
